5. The above church assumes full responsibility for the trailer while on their site. This includes flat tires or blowouts. Any damages to the trailer or its contents will be reported to the Piedmont Baptist Association upon return of trailer.
6. Piedmont Baptist Association assumes no liability for injuries or damage due to the use of the trailer or its contents.

It is your responsibility to arrange a time during PBA Office hours to pick up the keys to the unit you have reserved.
